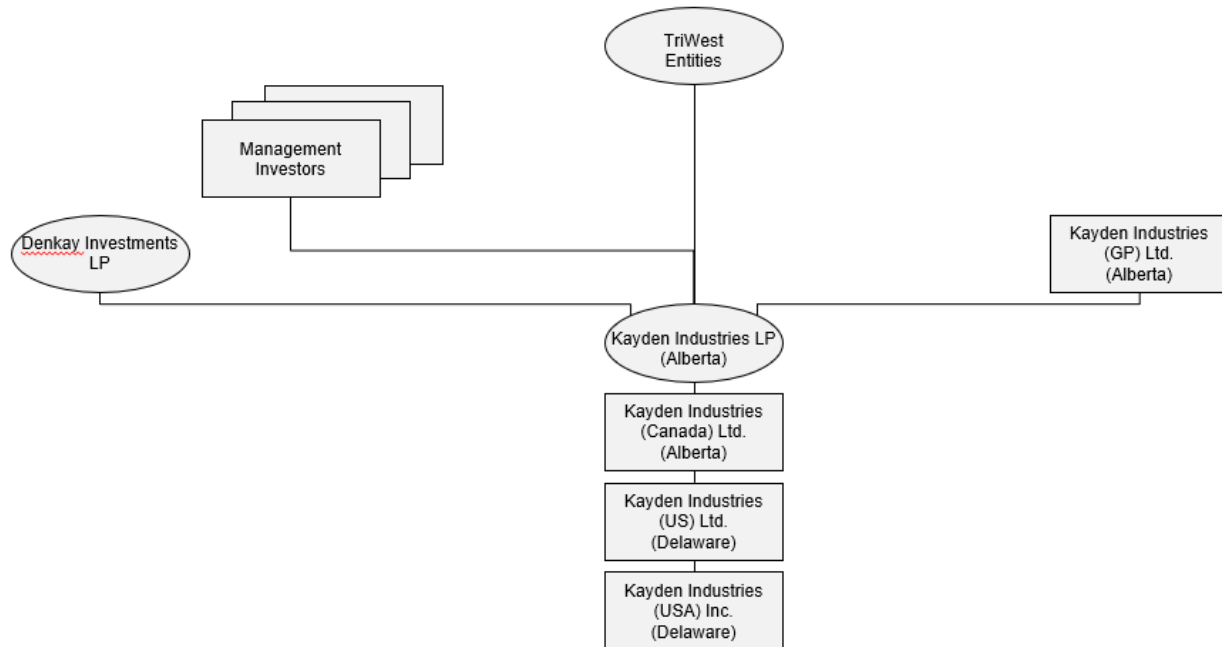

Child/Forced Labor Policy

Kayden Industries LP (“Kayden” or “the Partnership”) endeavours to provide a conducive working environment that is characterized by equality and mutual respect. Kayden will not tolerate the use of child or forced labor, nor exploitation of children in any of its global operations and facilities.

Kayden is committed to compliance with social standards and requires the same level of commitment from its suppliers. These standards set out the basic rights of employees and guidelines for environmental stewardship based on internationally recognized standards.

Child labour, as defined by the International Labor Organisation (ILO) Convention is “work by children under the age of 12; work by children under the age of 15 that prevents school attendance; and work by children under the age of 18 that is hazardous to the physical or mental health of the child.”

- Work that is mentally, physically, socially, or morally dangerous and harmful
- Work that fails to consider compulsory schooling
- Work that prevents children from attending school
- Work that makes it necessary for children to leave school prematurely
- Work that requires children to combine school attendance with long and heavy work

In the conduct of its business, Kayden:

- Will not employ children that fall into the definition as stipulated by the ILO Convention, notwithstanding any national law or local regulation.
- Will comply with all other applicable child labor laws, including those related to wages, hours worked, overtime and working conditions.
- Is against all forms of exploitation of children. The Partnership does not provide employment for children before they have reached the legal age to have completed their compulsory education, as defined by the relevant authorities.
- Expects its business partners and associates to have and uphold similar standards and abide by country-governing laws in the countries wherein they operate. Should violation of these principles become known to Kayden and not be remediated, Kayden will take serious action, including discontinuation of the business relationship.
- It is the responsibility of local management and Human Resources to implement and ensure compliance with this policy at all Kayden operations and facilities.

This policy is available to all team members as part of Kayden’s environmental, social and sustainability governance policies and procedures.

Preventive Strategy

Kayden will not tolerate or condone any form of child/forced labor and expects the same of its business partners. Acceptance of Kayden’s policies, which condemn and prohibit all forms of child/forced labor, is a basic prerequisite for establishing a business relationship with vendors.

Kayden requires its vendors to adhere to it’s Environmental, Social and Sustainability Governance program, which describes Kayden’s standards and expectations concerning Human Rights. Kayden commits itself to respecting and upholding Human Rights and requires it’s vendors, partners, and affiliates to do the same. Kayden is focused on strengthening its commitment to responsible and sustainable sourcing through identifying and selecting vendors who share similar values as well as ensuring Kayden delivers safe and high-quality products to Kayden’s customers.

Risk Assessment

The Kayden team will preform an annual SWOT analysis for weaknesses in the supply chain.

Import of Materials

Kayden will not import materials from unqualified vendors in areas of the world where there is a known high risk of Child/Forced labor.

Qualification of Vendors

Kayden will investigate vendors to ensure they have a Child/Forced labor policy in place that aligns with Kayden’s ideals and policies. Copies of vendor policies will be filed with their Vendor Qualification Packages. See Table 2 for the top raw material vendors and their policy statuses. If a vendor can not provide a written policy, within 6 months of request, an alternative vendor will be sourced until the vendor complies.

Internal Materials Audit

Kayden performs an internal inventory audit to confirm there are no raw materials in their current inventory sourced from known high-risk countries. If any raw materials sourced from high-risk countries is found, an investigation is undertaken and if required, the inventory is pulled from the shelf, returned to the vendor, and alternate materials from a different vendor will be purchased. The vendor who supplied any returned materials will be audited by Kayden to assess their compliance prior to re-establishing a vendor relationship with Kayden. 182 out of 353 items were sampled with no high-risk materials identified. See Table 1 for details of the sample chosen.

Recruitment

The Partnership will maintain records for all employees in the form of offer letters to demonstrate that all workers have been recruited voluntarily.

Training

Kayden will ensure all team members involved in procurement of goods are trained in all policies and procedures regarding Child/Forced labor, in accordance with the International Labour Organization. All team members, involved in procurement, have received mandatory training on this topic which is reviewed annually. Completed training is reflected in Kayden's in house training tracker. To ensure that all Kayden personnel are informed and educated on Child/Forced labor, Kayden distributes an information bulletin to all Kayden personnel annually.

Remediation

Based on the analysis performed for the reporting year, there has been no requirement to remediate any forced labour or child labour activities.

Review

Kayden will review this policy on an annual basis and update or revise as needed.
